





## **Dam Washing**

CORR-DEFENSE recognizes the intricate nature of managing oily residues within confined spaces and explosive zones. That's why our personnel undergo continuous training to execute these tasks with a focus on risk management. By doing so, we substantially minimize the likelihood of unforeseen events that could jeopardize the safety of personnel, facilities, and the environment.







Following the completion of oil drilling operations, CORR-DEFENSE offers extensive cleaning services for the surrounding area. This process includes authorized final disposal of residues located inside the sump and counter pit. Moreover, any areas potentially contaminated due to accidental spills are meticulously addressed. Soil scraping can be conducted manually or mechanically, with the contaminated soil transported for proper disposal. The production tree undergoes pressure washing, with residual water from the washing process efficiently removed. To complete the cleaning process, lime treatment is applied to the sump and counter pit.

- Management of required documentation in the various areas involved in the project.


